To: Members Glenrochie Country Club

The first of each year the Board of Directors and Management prepare a projection of income/expenses for the coming year.

- Revenue / Expense projections to provide proper funding for the daily operation of the Club.
- Capital improvements including major asset replacement.
- Review of anticipated borrowing needs and debt retirement for the coming year.
- Anticipated long term capital expenditures (known as a five-year plan).

Operating expense increased by 13.67% in 2024 compared to 2022. For the same period revenue increased by less than 5%.

In addition to operating expense the following capital improvement and major repairs were as following.

To complete the capital needs the club relies on income, and short-term borrowing.

The year end Note Balance for the past December 31st is as follows:

After review of the above the Board of Directors have approved the following dues increase as of April 1, 2025. This will be the dues billing starting March 31, 2025.

All membership categories will increase \$25 per month, except Tennis, Social & Youth. These will increase by \$10 per month.

For reference dues for full membership for 2014 was \$300 per month, for 2015 \$320 per month, for 2016 \$240 per month and from **2021 to the present \$225 per month.**


Message from the Pro, Chris Stacy
